Gaming Development News

Oxbow is concerned with several lawsuits spawned by proposed gambling development in Dearborn County.

Whiteco-Metrocomm, the company that wants to erect billboards in and around the Oxbow, sued in the Dearborn County court to have the decision of the Board of Zoning Appeals overturned. This Zoning Board decision denied Whiteco-Metrocomm's request for an exemption from the current zoning laws about sizes of billboards. The Dearborn County judge recently "threw out" the suit because it was not filed properly. Whiteco-Metrocomm can appeal, but has not yet done so.

In a federal case based on the same zoning decision, Whiteco-Metrocomm is asking to have the county's zoning code concerning billboards declared unconstitutional. In a preliminary telephone conference with the lawyers working on the case, the judge asked Whiteco-Metrocomm and the Board of Zoning Appeals to reach an agreement out of court. The Zoning Board will consider the matter at their next meeting, and a representative from Whiteco-Metrocomm has indicated that they are interested in reaching an agreement.

An out-of-court settlement seems likely in this case because the earliest possible court date is sometime in 1997. Presumably Argosy and Whiteco-Metrocomm would prefer to be in business before the case can be tried in court.

A grand jury in Indiana is investigating events leading up to Arogosy's obtaining the "certificate of suitability" for operating a gaming operation in Dearborn County. Records from local governments have been subpoenaed. Argosy has delayed a bond issue to raise funds for its Dearborn County development.


Birdathon '96

Field Notes Morris Mercer

Late winter and early spring have been great and it is nice to think of the beautiful days and remember the hours shared with so many nice folks. One afternoon, just as the sun was leaving the western sky at that special time when everything takes on a golden glow, we stood and watched great flights of Mallards, Blacks, and Pintail settle into the old cornfield along the Great Miami.

The large flights of migrant ducks were in the Oxbow a few weeks early this year. The weather and the water levels have been perfect for attracting ducks. I've seen more Canvasbacks than ever before. We had especially good numbers of Common Merganser, Goldeneye, Pintail, Widgeon, and Green-winged Teal as well. The large gangs of Mallards were here in February. People impatient for spring dread February, but this is one of the finest months at the Oxbow.

This last summer our family took a tour across the Dakotas, Alberta, Saskatchewan, and Manitoba — the North American Duck Factory — where we saw waterfowl in their summer home. This March, Frances and I joined up with our son David for a peek at some of the ducks on their wintering grounds.

David lives in Houston, Texas now and while we were there we took a day trip to the Attwater Prairie Chicken National Wildlife Refuge. The refuge is about 60 miles west of Houston. I was looking forward to seeing some Prairie Chicken again. I recall seeing them in the fields back in Illinois when I was a school kid. (Now that was a ways back!)

As we neared the refuge we turned on some narrow country roads and followed the signs. We saw Loggerhead Shrikes and Scissor-tailed Flycatchers on the wires along the road. We also saw Texas Bluebonnets and Indian paintbrush in bloom. We were watching for Prairie Chicken.

The land was flat and covered with low, dry brush. I thought of the old story about the land so flat that you could but down a 2 x 4 and back up water for 20 miles. But they're in the midst of a drought. We passed a few potholes where dead fish lay on the cracked dry bottom of what had been a water hole.

We stopped at a little shelter and picked up a brochure and field checklist. Frances was reading the brochure, which told us that there were fewer than 100 Prairie Chicken on the 8,000 acres of the refuge. And the area with the chickens is closed to the public. We passed the Refuge Headquarters and moved on down the auto tour route.

I asked Dave to stop, as I wanted to check a bird on a post. After a glance I asked Dave to get out the scope because we'd never seen a Crested Caracara. Dave pointed out a cloud to our southeast. It turned and the sunlight caught the white wings as we both said "Snow Geese."

Our map showed an area called "Pintail Marsh" down toward the flight of geese. We were anxious to move on. The land grew wetter as we moved toward the marsh. In the shallow water were Blue and Greenwinged Teal, Shovelers, White-faced Ibis, several Little Blue Herons, Great Egrets and shore birds. It was here we pulled over to let a car pass. (We only saw one other car during our 3-hour visit).

In the bright sunlight we put up the scopes to inspect Pintail Marsh. Dave said, "Look at this, Dad." I looked through his scope. There was a beautiful Cinnamon Teal in the foreground; behind him were both blue and white phase Snow Geese. A surprise to me was all the White-fronted Geese, almost as many as the Snow Geese. We found Ruddy Ducks and our first Mottled Ducks, along with more ibis and Blacknecked Stilts. Dave called me for another look through his scope — on a willow limb was a heavy-bodied snake sunning itself. On the willow next to it were three more that looked just like the first one.

Dave had to get his mother over for a look. She had the reaction he expected, claiming that it reminded her of Indiana Jones in *Raiders of the Lost Ark*. The brochure said we might see King or Rat snake or Cottonmouth. We didn't check the insides of the snakes' mouths, but I'd bet they were white. We left them in the warm sun.

It was great fun to share a scope with Dave again, and to visit an area where some of our migrant waterfowl spend the winter. These birds winter on the Gulf Coast, South and Central America and each summer they fly as far as the Arctic Circle. I sure enjoy seeing those that stop at our Oxbow to rest and feed.

1996 has been great so far out at the Oxbow, and now I'm looking forward to spring. Have you seen the "Potted Owls" yet? If not, you'd better hurry!

Treasurer's Report 1995 Oxbow Inc.

Oxbow's land was surveyed and marked last year -- for an expenditure of about \$14,000 -- to forestall potential and actual encroachment by developers, vandals, and dumpers.

Other threats to the Oxbow arise from proposals made by various corporations, local governments and others to construct roads, billboards, levees and otherwise develop the refuge. Oxbow, Inc. continued to meet these challenges, defending the wetland before various boards, commissions, authorities and private interests at a cost of about \$24,000 for legal expenses.

Net income declined in 1995 largely because the special court-ordered pollution donations expired in 1994. Dues and Birdathon revenue also waned, but interest income increased significantly. Expenses declined except for the legal and survey expenditures discussed above.

Assets increased more than \$33,000 in 1995.
